**RMHA exhibitors must follow RMHA show attire rules as follows:**

#### **Under Saddle Class:**

##### **1. English Attire:**

- a. Solid colored or conservative patterned riding skirts or Kentucky Jods with tie downs (underpasses).
- b. A vest with riding coat or sports coat or a riding suit.
- c. Long sleeve shirt with a pointed collar including tuxedo shirts (sleeve length may vary under a coat).
- d. Neckwear such as a tie or brooch.
- e. English style hat is optional.
- f. Protective headgear is acceptable.
- g. Gloves and English spurs are optional.
- h. English style boots.
- i. English whip/crop is optional (neither is to exceed 40 inches or 44" with popper).

##### **2. Western Attire:**

- a. Western slacks or black jeans; Western show skirts optional for women.
- b. Western style jacket, bolero or vest is optional.
- c. Any solid colored pants (including blue jeans) are acceptable under chaps.
- d. Western long sleeve shirt or slinky (sleeve length may vary under a jacket).
- e. Neckwear such as a tie, bolo, or neck scarf (not required with a slinky).
- f. Gloves are optional; Western hats (Spanish or ASTM – approved or SEI-certified headgear acceptable) are optional.
- g. Western style boots (no tennis or sport shoes)
- h. Chaps, spurs and gloves are optional.

**3. Country Trail Pleasure Class Attire: English or Western attire may be used (with appropriate tack) but not a combination of both.**

- a. Coats or jackets are optional with English attire.
- b. Black jeans and pants without tie downs are permissible in this division.

**4. Trail Pleasure Class Attire: English or Western attire may be used (with appropriate tack) but not a combination of both.**

- a. Coats or jackets are optional with English attire.

**5. Show Pleasure Class Attire: English attire (Coats are required in this division).**

**6. Western Pleasure Class Attire: Only Western attire may be worn with Western tack/equipment in Western designated classes. Spanish style attire will be accepted.**

**OGB = Open Gaited Breed (Texas Only Class)**

**TP = Trail Pleasure TWH horses may enter OGB classes but not Country Pleasure or All Day Pleasure.**

(Exception: Spotted Saddle horse classes and all Versatility, Model, Showmanship and Equitation).

**CP = Country Pleasure TWH horses may Cross enter OGB & ADP classes but not Trail Pleasure.**

(Exception: Spotted Saddle horse classes and all Versatility, Model, Showmanship and Equitation).

**ADP = All Day Pleasure Horses may Cross enter into Country Pleasure but not Trail Pleasure.**

(Exception: Spotted Saddle horse classes and all Versatility, Model, Showmanship and Equitation).

**Youth = Ages 17 and under**

**Novice Rider** has not won a 1<sup>st</sup> place at a Highlander Gaited Horse Show. Wins on the day of show do not count.

**Amateur:** A person is an amateur for horse show purposes who, after his / her 18th birthday, does not engage in any activities which would cause him/her to be classified as a professional.

**(AOT) Amateur Owner Trainer:** Amateur Owned and Trained Classes are open to horses that are **owned by an amateur, trained by an amateur and exhibited by an amateur.** The horse cannot be ridden, trained or schooled by a professional trainer for 90 days prior to being shown in an Amateur Owned and Trained Class. **A person** must be inactive as a Professional for the same period of time

he/she was a Professional for up to five years maximum.

**55 & Over:** This class is the **COMBINED** age of the Horse & Rider.

**Matched Pairs:** Two horses will ride the rail class as a team (side by side). Best matched pair in all gaits wins.

**DRESSAGE:** The Dressage tests will be ridden on **SUNDAY**. One-hour ride time **BLOCKS** be issued. **YOU MUST PRE-REGISTER for the dressage tests NO LATER THAN Wednesday at 5:00PM. Cost per ride is \$20. Ride times will be posted on Highlander Ranch Facebook page.**

# HORSE SHOW AGREEMENT AND LIABILITY RELEASE FORM

1. **REGISTRATION OF RIDERS AND AGREEMENT PURPOSE** In consideration of the payment of a fee and the signing of this agreement, I, the following listed individual, and the parent of legal guardian thereof if a minor, do hereby voluntarily request and agree to participate in a horse show at MCC Highlander Ranch.

2. **AGREEMENT SCOPE AND TERRITORY AND DEFINITIONS** This agreement shall be legally binding upon me the registered, and the parents or legal guardians thereof if a minor, my heirs, estate, assigns, including all minor children, and personal representatives; and it shall be interpreted according to the laws of the state of Texas. Any disputes by the rider shall be litigated in and venue shall be in McLennan County, Texas. If any clause, phrase, or word is in conflict with state law, then that single part is null and void. The term "HORSE" herein shall refer to all equine species. The term "HORSEBACK RIDING" herein shall refer to riding or otherwise handling of horses, ponies, mules, or donkeys, whether from the ground or mounted. The term 'RIDER' shall herein refer to a person who rides a horse mounted or otherwise handles or comes near a horse on the ground. The terms 'I', 'ME', 'MY' shall herein refer to the above registered rider and the parents of legal guardians thereof if a minor.

3. **ACTIVITY RISK CLASSIFICATIONS** I UNDERSTAND THAT: Horseback riding is classified a RUGGED ADVENTURE RECREATIONAL SPORT ACTIVITY, and that there are numerous obvious and non-obvious inherent risks always present in such activity despite all safety precautions. According to NEISS (National Electronic Injury Surveillance Systems of United States Consumer Products) horse activities rank approximately 64<sup>th</sup> among the activities of people relative to injuries that result in a stay at U.S. hospitals. Horseback riding and/or the handling of horses or other equine species may result in accidents that may result in injury or death. Related injuries can be severe requiring more hospital days and resulting in more lasting residual effects than injuries.

4. **RIDER RESPONSIBILITY** I UNDERSTAND THAT: Upon mounting the horse and taking up the reins the rider is in primary control of the horse. The rider's safety largely depends upon his/her ability to carry out simple instructions and his/her ability to remain balanced aboard the moving animal. I agree that the rider shall be responsible for his/her own safety, including that of an unborn child, if the rider is pregnant. Pregnant women should only ride horses under the advice of their physician. MCC HIGHLANDER RANCH advises pregnant women not to ride horses.

5. **CONDITIONS OF NATURE AND INSPECTION OF PREMISES:** I UNDERSTAND THAT: MCC HIGHLANDER RANCH is NOT responsible for total or partial acts, occurrences, or elements of nature that can scare a horse, cause it to fall, or react in some other unsafe way. SOME EXAMPLES ARE: Thunder, lightning, rain, wind, wild and domestic animals, insects, reptiles, which may walk, run, or fly near, or bite or sting a horse or person; and irregular footing on out-of-door groomed or wild land which is subject to constant change of condition according to weather, temperature, and natural and man-made changes in landscape, public and private roadways, other riders, walkers or bikers, areas of heavy traffic motorized and not motorized vehicles. The rider and parent or legal guardian have inspected MCC HIGHLANDER RANCH'S facilities' and are satisfied that all premise conditions are reasonably safe for rider's intended purpose, usage, and presence upon MCC HIGHLANDER RANCH'S PREMISES.

6. **SADDLE GIRTHS/NATURAL LOOSENING** I UNDERSTAND THAT: Saddle girths (saddle fasteners around horse's belly) may loosen during a ride. If a rider notices this he/she must alert the riding instructor as quickly as possible so action can be taken to avoid slippage of saddle and a potential fall from the animal.

7. **INSURANCE** I UNDERSTAND THAT: MCC provides no insurance which would pay for medical treatment arising from participating in this program.

8. **PROTECTIVE HEADGEAR WARNING** I AGREE THAT: I for myself and on behalf of my child and/or legal ward have been fully warned and advised by MCC HIGHLANDER RANCH that protective headgear which meets or exceeds the quality standards of the SEI CERTIFIED ASTM STANDARD F 1188 or later Equestrian Helmet, should be worn while riding and being near horses and I do understand that the wearing of such headgear at these times may reduce severity of some of the wearer's head injuries and possibly prevent the wearer's death from happening as the result of a fall and other occurrences.

9. **GENERAL CONDUCT POLICY**

I AGREE THAT: I for myself and on behalf of my child and/or legal ward to obey the MCC Highlander Ranch Rules and the MCC General Conduct Policy, which can be found on the MCC website, [www.mclennan.edu](http://www.mclennan.edu) (Key search words "General Conduct Policy") Examples are, no smoking, dogs are not allowed on the Ranch property, the speed limit is 15 MPH.

**Failure to follow these policies and rules may result in dismissal from the Highlander Ranch.**

10. **LIABILITY RELEASE** I AGREE THAT: In consideration of MCC HIGHLANDER RANCH allowing my participation in this activity, under the terms set forth herein, I, the rider, for myself and on behalf of my child and/or legal ward, heirs, administrators, personal representatives or assigns, do agree to hold harmless, release, and discharge MCC, its agents, employees, officers, directors, representatives, assigns, members,
